Sliding Scale Fee Policy:

Our sliding scale is based on a discussion with the client about the state of their finances. Financial assessment happens within the first 2 sessions, and we can revisit every 30 days thereafter.

Diagnostic Intake Fee: \$300/hr Normal Rate; reduced to \$250/hr Sliding Scale Rate.

Individual Psychotherapy Session Fee: \$250/hr Normal Rate; reduced to \$200/hr Sliding Scale Rate.

Family/Couples Counseling Fee: \$250/hr Normal Rate; reduced to \$200/hr Sliding Scale Rate.

Telehealth Sessions (via Zoom for Healthcare Prof.) Fee: \$250/hr Normal Rate; reduced to \$200/hr Sliding Scale Rate.
Group Session Fee: \$35/hr - No Reduced Sliding Scale Rate.
